2021 VIRTUAL ENVIROTHON TEAMS

This past Spring, Defiance County had 7 teams compete in the 2021 Virtual Envirothon. Participating teams are made up of 5 high school students that are tested on subjects such as forestry, soils, wildlife, and aquatics. Area 1 had 27 teams competing and Ayersville High School came in 9th & 24th place. Fairview High School teams placed 3rd, 18th, and 23rd. Tinora High School took 14th & 17th place in the competition. Teams were able to study with the Defiance SWCD Education & Outreach Coordinator through a new online portal. The portal had videos from several natural resource professionals, quizzes to test their knowledge, and other study materials to prepare them for the competition.

H2OHIO UPDATE

As the H20hio program continues to ramp up, Amy Birtcher our H20hio Specialist has a few things to remind producers of that are enrolled into the program.

- Verification forms that were emailed out in November 2020 to the producers involved, are not due in the office until the practice is finished. In order to get payments, those will need to be completed, signed, and approved.
- As producers are making fall and spring applications, as-applied maps are a requirement for the program and will need to be turned in to the office.
- Payments for the Voluntary Nutrient Management Plans, fall phosphorus application, and spring phosphorus applications will be in June, once verification forms are turned in and approved.
- Agreement extensions will be tentatively signed in July. More information will be coming out in the future

The Voluntary Nutrient Management Plans were due on April 1st.

Ohio Agricultural Conservation Initiative farmer profiles were due March 31st.
